TERMS AND CONDITIONS

For the consideration of the extension of credit, the Applicant promises to pay to the order of New West Co. within 30 days following the date of the invoice. Accounts 31 days past due will be charged interest at the rate of 1-1/2% (18% APR) per month from due date until paid. Accounts over 60 days delinquent may be subject to a credit hold. The Applicant further agrees that if the payment is delinquent and placed for collection the Applicant agrees to pay all reasonable court costs attorney fees and other expenses paid or incurred to collect, as provided by law. In jurisdictions where a state rate is required, reasonable attorney's fees will be 15%. This Agreement shall be construed and interpreted in accordance with the laws of the State of Missouri. The parties hereby stipulate that any action to enforce any provision of this Agreement shall be filed within the County of Jackson, State of Missouri in an otherwise appropriate state or federal court.

The Applicant agrees that it has been issued a Certificate of Authority to collect state and use tax within the state listed in the first section of this application, and this certificate has not expired or been suspended or revoked. The Applicant states that all of the tangible personal property purchased from New West Co. will be purchases for resale in the ordinary course of the purchaser's business and therefore is exempt from sales or use taxes. The Applicant agrees that it will assume all liability for the payment of any tax that may be due under the above numbered tax permit if this transaction is not exempt from such tax.

The Applicant agrees that if payment is made by check that is dishonored or returned unpaid or any reason, New West Co. may charge and collect the amount of \$30.00 dollars plus an amount equal to the actual charge by the depository institution for the return of each unpaid or dishonored instrument.

The Applicant shall notify New West Co. in writing within thirty (30) days from the delivery of the product or materials of any defects or inadequacies in the product or materials provided. Acceptance of product or materials by the Applicant after thirty (30) days from the date of delivery shall be construed as an approval of quality or workmanship and will constitute a waiver of any defects or inadequacies.

The Applicant certifies (1) the information provided is true and correct and has been submitted to obtain commercial credit; (2) I am authorized to execute applications and other documents required to establish commercial credit accounts on behalf of the Applicant; (3) New West Co. is authorized to inquire of principal trade creditors, banks, and other credit references to check the Applicant's credit history, and authorizes New West Co. to answer questions from others about credit experience with the Applicant from time to time in connection with the extension or continuation of the business credit represented by this credit application; and (4) I have read, understood, and agreed to all the Terms and Conditions and agree to notify New West Co. in writing of any change in the form of the Applicant's business or ownership within five (5) days of such change (otherwise, the terms of this application shall extend to the applicant and all successor companies jointly and severally.) (6) Applicant authorizes New West Co., at its discretion, to make charges on the credit card provided for any unpaid balances. The extension of credit shall be within the sole discretion of New West Co. The Applicant agrees and consents that facsimile signatures shall be deemed original signatures for all purposes in connection herewith.
